## Shelly's RECIPE CORNER

### BEST EVER SUGAR COOKIE RECIPE



*This recipe was shared by one of our avid newsletter readers, Perry Baxter.*

*We hope you enjoy these yummy cookies as much as we do. Thanks for sharing, Perry!*

#### Ingredients:

1 cup butter, softened	4 cups flour
¾ cup cooking oil	2 eggs, lightly beaten
1 cup powdered sugar	1 tsp. cream of tartar
1 cup white sugar	1 tsp. soda
2 tsp. vanilla	

#### Directions:

Preheat oven to 350 degrees.

Cream butter, oil and white sugar. Add eggs, vanilla and sifted dry ingredients.

Roll into small balls and flatten on a cookie sheet with bottom of glass dipped in sugar.

Bake for 8-10 minutes (until very lightly browned). Makes about 7 (yes, seven!) dozen cookies.
